When renewing a Contractors/Manufacturers license, the licensee shall pay a license fee at the rate of .00046 of the aggregated gross receipts; provided, however, that the minimum license fee shall be one hundred and twenty-five dollars (\$125.00).

Merchants and Bottlers 63.00

When renewing a Merchant/Bottlers license, the licensee shall pay a license fee at the rate of .00046 of the aggregated gross purchases for resale; provided, however, that the minimum license fee shall be sixty three dollars (\$63.00).

Sports Betting and Horse Racing 125.00

When renewing a Sports Betting/Horse Racing license, the licensee shall pay a license fee the rate of .00046 of the aggregated gross receipts (defined as commission) for the activity; provided, however, that the minimum license fee shall \$125.00).

Gaming Position 155.00

Gaming position means every individual space or seat, whether standing or sitting, authorized to conduct gaming activities as identified on an approved floor plan.

Coin Operated Vending Machines

A list of the location for each vending machine located within city limits of Dover will need to be provided each year.

Section 2. Licenses shall be required for the following trades, businesses, and occupations in the City of Dover, and the license fee shall be set forth beside the names of said trades, businesses and occupations in the City of Dover.

Section 4. Each license granted under this ordinance shall not be transferable.

Section 5. License shall be displayed in a conspicuous manner in the principle office in the place of business in the City of Dover.

Section 6. Any person convicted of a violation of the provisions of this ordinance shall be fined not less than ten dollars (\$10.00) nor more than one hundred dollars (\$100.00), or upon failure to pay such fine as shall be imposed, shall be imprisoned for not more thirty days.

Section 7. The premises of every license shall be open to inspection of the Fire Marshal and the Executive Officer of the Board of Health during all business hours.

Section 8. All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Section 9. In the event that the license fee is not paid on or before August 1st of each year, then the license fee shall incur a penalty of the amount of ten (10%) percent per month of the amount of license fee until the same is paid. Each day the license fee is delinquent and not paid shall constitute a separate violation and a summons may be issued to initiate a criminal prosecution for each day that the license fee goes unpaid.
