Certificate of Occupancy There is an application fee for each Certificate of Occupancy. (temporary and permanent) the fee is calculated as follows: Certificate of occupancy for one family residential uses -\$60.00

Fire Sprinkler Permit Fees \$25.00 per thousand dollars of construction or multiple thereof with a minimum fee of \$150.00 per permit.	 Temporary certificate of occupancy for one family residential uses—\$75.00 for a max of 45 days. Fee applies for any extensions beyond 45 days. Certificate of occupancy for uses other than one family residential uses—\$75.00 for the first 20,000 square fee of building area, plus the sum of \$15.00 for each additional 10,000 square feet of building area in excess of the first 20,000 square feet or multiple. Temporary certificate of occupancy for uses other than one family residential uses—\$100.00 for 45 days. Fee applies for any extensions beyond 45 days.
